Department of Empowerment of Persons with Disabilities invites applications through National Institutes/CRCs for reimbursement of tuition fee to 100% Blind & 100% Deaf (without cochlear implant) students in STEM subjects from classes 9th to 12th under National Fund for PwDs.

Purpose:

Reimbursement of tuition fee to 100% Blind & 100% Deaf (without cochlear implant) students pursuing STEM subjects from class 9th to 12th.

Eligibility Criteria	<ul style="list-style-type: none"> Open only for Indian nationals. 100% Blind & 100% Deaf (without cochlear implant) students pursuing STEM subjects from class 9th to 12th. Maximum annual family Income- up to Rs. 8 Lakh from all Sources. Maximum 1000 students can be considered for reimbursement of tuition fee in a certain Financial Year. Not availing any other scholarship/stipend. Not more than two children with disabilities of the same parents will be entitled to receive benefits of this scheme. In case the second child is a twin, the fee reimbursement under the schemes will be admissible to the twin.
Extent of Financial Assistance	<ul style="list-style-type: none"> Rs. 1.5 Lakh or actual whichever is less per year per student. Financial assistance will be provided with due approval of the Governing Body of National Fund in two equal installments to the concerned NIs/CRCs (a) 50% on confirmation of admission (b) Remaining 50% fee will be released after completion of mid-term examination.

School ID or Bona fide certificate. Class 8, 9, 10, or 11 mark sheets (as applicable). Copy of the affiliation letter of the School. Self declaration regarding not availing any other scholarship/stipend for the same course
